### WELCOMING COMMITTEE

Many properties have changed hands in 2017-18, our committee has had the privilege to call on many of you and welcome you to Silver Lake. If you are new and we haven't met you yet, or if you have a new neighbor we aren't aware of, please contact me so that we may remedy this and get acquainted!

The SLIA stepped up to address the problem, resulting in our current overflow drain being approved by the court and in operation in early 1987.

The cost was approved by 65% of residents and shared through a special assessment, which has also covered the maintenance over this last 32 years.

G.T. County Drain Commissioner Steve Largent graciously presented an update on the current standing of the drain at the SLIA annual meeting in August. As we reported in our spring newsletter, Steve, along with volunteer lake residents cleaned the screen and kept the drain open throughout the winter and spring. Steve also has plans to lift the screen this fall and explore the outlet structure for any obstructions, including using a camera

removed. The drain field will be reinforced with filter fabric under an appropriate rock layer around the structure. While it has been functioning for these 32 years, it is advisable to take steps to keep it that way! There are also future plans for a camera to be installed to further facilitate monitoring of the flow. Steve is available for questions at slargent@ grandtraverse.org or 231-409-9314. The county has advanced funds to cover these maintenance costs while the previous assessment is updated, this assessment is relatively small compared to the benefit! If you have questions, please send them to the website. Note - the established level is 862', at this time it is 861.5' after recent rains, though it seems quite high, it doesn't compare to the 3 feet higher in 1986 when this initiative was started!



### **INVASIVE SPECIES – INFO & TREATMENT!**

The introduction of Invasive Species plants into the Great Lakes and ultimately into inland lakes in Michigan and surrounding states several years ago has become a large problem that has to be dealt with. Some very proactive SLIA board members at the time instituted treatment, through a special assessment supported by Silver Lake Property owners, along with help from the Townships to treat it for containment. It proved to be unrealistic to believe it could be completely eradicated, but due to continued vigilance through the years it has been considerably contained. In fact, Silver Lake proves to be one of the cleanest lakes in the region!

Eurasian Water Milfoil (EWM) is

the largest threat, see illustration above, as well as pics to the right of lakes in Southern Michigan that have "Out of control invasions". If you see this plant - PLEASE DO NOT PULL IT! Any small fragment will restart another plant! Instead contact the SLIA board with the location and it will be scheduled for treatment.



There are several items to talk about in this fall report. First and foremost is the treatment for Eurasian Milfoil (EM). (See article above.) There were 10 Acres of EM treated in late June. I have been noticing many areas where it is re-emerging recently. I will be contacting RLS to schedule the fall lake survey and possible fall treatment. If you notice an area where there is EM, please notify me at SLIA. We must continue to actively work to contain this invasion as best we can!

Purple Loosestrife - This is an invasive plant that can take over your waterfront in short order. If you have it, dig it up by the roots, be sure to

please drain at least once per year. If you see evidence of systems leaching into the

lake, please contact the appropriate authorities!



cover the flowering portion of the plant to contain the seeds from spreading prior to digging, then dispose of properly.

Fall clean up - please do not rake your leaves into the lake, leaves in the lake equal phosphorus equal muck! If you use a service to clean up your yard, be sure that they haul the leaves away.

Septic tanks - If you have a drain field, please make sure to drain your septic tank at least once every 3 years. If your septic drains into a dry well,
