A GOOD TIME TO SPEAK UP

As you may already know, Garfield Township has purchased an 85-acre parcel northeast of Silver Lake for a park. Roughly 60 people attended a meeting held to gather input from the community regarding activities residents would like to see in the park. Aaron Mead, Garfield Township Deputy Supervisor, conducted the meeting.

Aaron showed some conceptual drawings that showed some potential uses. They included both active activities like baseball, soccer and tennis as well as passive activities like hiking, picnicking and bike riding. A citizen committee will be formed to analyze suggestions and make recommendations to the Township board. Let Aaron know what activities you would like to see in the park. Aaron will pass on information to the committee *(see Aaron's contact information below)*.

Other issues brought up at the meeting are:

BOATING AND SWIMMING

Concerns were expressed about noise and traffic problems if park lake frontage is used for boating and swimming. Aaron Mead indicated the township feels Silver Lake is already heavily used and there is no intent to develop a boat launch or swimming area. However, given the swimming activity at the public boat launch, it is likely there will be pressure at the park as well. Special effort may be required to prevent such activity. PARK ACCESS

The lack of bike and pedestrian walkways to get to the park from township residential areas was noted. Adding walkways to existing roadways is a County Road Commission function. Express your wishes for pedestrian walkways on existing roads to county officials *(contact information below)*.

FISHERY IMPROVEMENT

The lack of fish in Silver Lake is a frequent topic of discussion. One presumed cause is reduction of spawning habitat that has occurred as lakefront properties have been developed. A small channel between Silver Lake and the pond to the north would provide access for adult fish from the lake to the spawning habitat in the pond, Pike being the primary beneficiary. This idea has been discussed with former DNR fish biologist Ralph Hay, who thinks the channel is a good way to improve spawning habitat. An open channel a few feet wide would be adequate. A small bridge or barrier would prevent boat traffic in the channel. An 1881 plat book shows the pond being a part of the lake. Aerial photographs dating back to 1938 show a barrier between the pond and lake. Please express your feelings pro or con regarding a channel to Kevin Gagnon or Russ Adams (contact information below).

PARK PROPERTY DESCRIPTION 128 feet of frontage on Silver Lake.

West boundary: The west shore of the 14-acre pond at the north end of the lake.

East boundary: East Silver Lake Road.

South boundary: About 1000 feet north of Silver Pines Road.

North boundary: The southerly edge of the stand of pines. The township has several diagrams (including possible uses) and overhead photographs that can be viewed at the township hall.

WATER QUALITY MONITORING

Silver Lake Improvement Association (SLIA) is participating again this year in the Cooperative Lake Monitoring Program (CLMP) sponsored by the Michigan Department of Environmental Quality and the Michigan Lake and Streams Association.

In this program volunteers provide the labor to collect data and water samples for testing to determine the water quality of the lake and water quality trends of the lake as the quality changes over time. Recent additions to the testing program include a survey of lake aquatic plants and fish evaluation.

This year SLIA will participate in water clarity, phosphorous, chlorophyll a and dissolved oxygen tests. For more information on these tests and what the results mean, visit the Michigan Lake and Stream Associations and DEQ websites (www.mlswa.org and www.mlswa.org and www.mlswa.org (or the DEQ site , click on water, click on inland lakes and streams, click on water quality monitoring, click on Inland Lakes monitoring. Results of last years Silver Lake water clarity and phosphorous testing can be found at this DEQ location also.

Water clarity is measured weekly from May through September. Phosphorous testing is done in the spring and again in the fall. Chlorophyll samples are collected once a month. Dissolved oxygen and temperature profiles from lake surface to bottom are taken three times during the summer. All measurements are taken at the 96 foot deep point of the lake.

Connector Proposed

The Zimmerman Park project has presented an opportunity to improve fishing in Silver Lake. In order for any fish species to survive and perpetuate, they need suitable spawning habitat. Net surveys in Silver Lake indicate a decline in the northern pike population. This toothy predator is an important link in the food chain. As weeds become sparse due to loss of shoreline cover, so do the fish nurseries that insure survival of fingerlings. The marshy area bordering the park property on the west is a prime fish rearing area. At the planning meeting for the park, it was suggested that a covered, notnavigable connector be considered during the planning stages, to allow fish migration between Silver Lake and what is now called North Silver Lake. Contingent on approval of the DNR, this project seemed to be favorably received. We'll keep you informed of any developments.
