## 4TH OF JULY BOAT REGATTA

Wow! It is hard to believe another year has gone by. We were greeted with an unusual start to spring and all of us began to think, "Let's get out on the water!" Then reality set in when I awoke to find snow on a vehicle. Hopefully we will get back on track and the weather will be beautiful for Regatta 2010.

Speaking of the regatta, we will be making a few changes this year. First, we have decided to move up the start time to 2:00. We will all gather at the regatta staging area, the public boat launch, at 1:45. Here you will be given a registration form to fill out. You will also be given a number that we ask you to adhere to the shore side of the boat. This will be used by the judges to identify boats as we cruise around the lake. All judges will be given a scoring sheet to use to help uniform the judging process.

We ask that all boats remain in the parade throughout the event, stick close to the boat you are following, and come to the staging area at the boat launch for door prizes and camaraderie at the close of the parade. As always, the official winners will be announced and awarded at the Silver Lake Improvement Association meeting in August.

I know that many of you have been working all winter on ideas for your entry. In my opinion it will be hard to top 2009. Best of luck and see you on the 4th!

## Invasive Species Control

Last year \$23,915 was spent on treatment to reduce Eurasian Milfoil in Silver Lake and to control phragmites. Additional monies were spent on legal fees, advertising and mailing in connection with setting up the Special Assessment Districts. Renovate OTF was the herbicide used last year with mixed results.

This year, on the applicators recommendation, Navigate herbicide will be used where usage restrictions allow and continue to use Renovate OTF elsewhere. Navigate is a tried and tested product the applicator has confidence in.

Michigan restricts the use of Navigate within certain distances of water wells. We have been building a well data base (well depth and distance from shore) for the 380 or so parcels with Silver Lake frontage so we can observe the restrictions. We have obtained available county health department well depth information.

An April mailing to 130 property owners requesting well information produced some 50 replies. Lake association board members have been going door to door obtaining well information for the balance.

## Can You Top This?????

On April 1, 2010 many of you may have heard a loud scream from the North end of Silver Lake. If so, it was the sound of Brendan Fowler, the 8 year old grandson of Andrew and Trudy Fowler, jumping off his grandparent's raft. has been cancelled again this year. If you are interested in getting something going again please contact our Fisheries Committee chair, Larry Wesholski, at 943-0632.

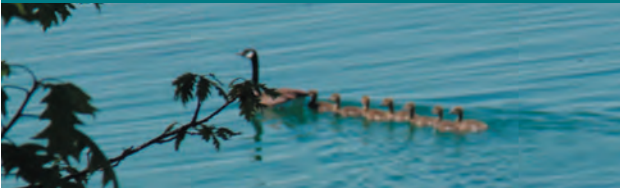
## ANNUAL MEETING

## CONTINUED KEYHOLING CONCERN

We continue to be concerned about the lack of adequate restrictions regarding the "Easement to Water Front", (keyholing) ordinances in Garfield and Blair Townships. We have sent letters to both townships advising them of the excess boat capacity on silver lake and the concerns about future development that could only put further pressure on the lake. We have learned that Garfield Township is in the process of rewriting their zoning ordinance and expect to complete that task in 2011.

As development has slowed due to the lackluster economy now is a good time to push the townships to address this situation before the economy improves and potential development becomes more feasible. There are model ordinances suggested by the Michigan Lakes and Streams Association, that will be recommended to the townships as a possible solution.

You can help move this process along by writing letters to Garfield and Blair Townships requesting that their Easement to Water Front ordinances be revised to provide better protection from over crowding on the lake.

We will attend the appropriate meetings to make our case. Hopefully the administrations will realize the importance of the residents of Silver Lake to their townships and they will work with us to make the necessary changes and improvements in the ordinances to keep Silver Lake a clean and attractive place to live.

## NESTING SWANS

There is a pair of nesting swans on the south end of the north-most island (across from the Old English Subdivision access). This particular area is highly accessed by swimmers, kayakers and paddle boaters due to the close proximity to the subdivision's access. Please be reminded that these birds are very protective and can be aggressive. You should not try to access the area; but leave them alone. Two years ago, I personally saw a male swan, protecting his nest, go after a swimmer. Luckily, a boater saw the distress and herded the swan away. While very pretty, these birds are large and strong. I hope we can go without an incident this summer.
