### BITS FROM THE PAST

Russ and Pat Adams are the sources of information that focuses on the north end of Silver Lake. Their property abstract dates back to 1856. Their land was part of the development known as Prospect Park, platted in 1912. A read of the abstract yields many familiar names in the area, among them Dunn, Kratochvil, Robertson, Birkholm.

Russ's family was introduced to Silver Lake in 1914 by his grandmother. In 1935, in the midst of the Great Depression, his parents bought a cottage on the north end for \$1400. They paid \$15 per month and owned it by 1939. They rented it out to resort visitors, mainly from the Midwest, in order to make the payments. Most renters stayed two to three weeks and enjoyed the rustic amenities that included a hand water pump, outhouse, and ice box. By 1951 the property taxes were \$7.64.

Spending his boyhood summers on the lake, Russ picked cherries for 35 cents per lug, helped with the hay and spud potatoes on the Robertson farm (with ice cream as a reward), picnicked by Harbor Court, and enjoyed the usual lake activities.

In 1952, his life changed forever when he met 16year-old Pat at a birthday party. He overturned her in a canoe and she eventually married him anyway! They dated through high school and married in 1958. Then it was college at Central Michigan College (now CMU) and then on to MSU for Russ and an engineering degree. They had two kids by the end of college and went off to Seattle where Russ was employed by Boeing. But Silver Lake beckoned.

In 1981, Russ and Pat bought a piece of property two doors down from the original Adams cottage. Their sprawling lot included a 600 square foot stone cottage and a stone boathouse. In fact, there were stone structures everywhere – a stone arch, stone basement, stonewalls around flowerbeds, stone flowerpots and stone pillars. The lore suggests that a previous owner had an affair with the bottle and his wife kept him busy hauling stones from the lake for numerous projects.

In 1999, Russ and Pat built their present home. They converted the 1925 boathouse into a guest cottage and added a large garage to house all the things that accompany lake living. Their beautiful home with the most amazing view of the length of Silver Lake continues to host the 5:00 bell, a tradition begun by the previous owners. People meet when the antique bell is rung and enjoy libations and conversation. They have hosted three weddings, family reunions and numerous parties. Many SLIA board meetings are held there.

The Adams have been at the core of the SLIA in many capacities for about a decades. Their stewardship of the lake includes Pat currently, and for several years, serving as secretary of the SLIA. She is also in charge of the newsletters, from creation to distribution. Both have served several terms on the board. Russ has been the point man in the environmental issues of Silver Lake, testing for water quality at least once per week and spearheading the efforts to control invasive species such as Eurasian milfoil, purple loosestrife, and phragmities.

## ARE YOU FOLLOWING THE RULES?

Please read the enclosed brochure put out by the Michigan Lake & Stream Association, Inc. so you and your guests are aware of the regulations while boating on Michigan Lakes.

Barry Andrews, a SLIA board member, recently talked to Sergeant Chris Oosse (officer in charge of our local marine patrol) about citations given on Silver Lake during the summer season of 2010. He reported that citations are up from previous years. BUI (boating under the influence) arrests were up and there was an increase in the number of complaints regarding loud music (primarily for boats wakeboarding)

Barry was able to obtain a chart with the number of warnings and citations for all the lakes in the Grand Traverse area. If interested in obtaining this information go to our web site at www.silverlakeimprovement.com.

If you want to report a violation call the nonemergency central dispatch number 231-922-4550. (911 should always be called in case of an emergency). The violation is recorded and if a deputy subsequently sees the violation again, it will likely result in a citation rather than a warning. Make sure you get the MC number of the boat, description of the operator , nature of the violation, location, date and time. The more information you have the easier it is for the violation to be dealt with. Date stamped photos or video of the violation is very helpful in processing the violation.

We want everyone on our lake to have fun but we also want everyone to be safe. PLEASE, know the rules and make sure everyone follows them.

## **INVASIVES CONTROL**

Late last year, on the recommendation of the SLIA board, Blair and Garfield Townships hired a lake manager (Lakeshore Environmental of Grand Haven) for the invasive species control effort. A major consideration in hiring the lake manager was to maintain continuity in the control effort. Secondarily, the applicator we used the past two years was asking for sharply higher rates that the lake manager could likely improve on. That turned out to be the case. Lastly, we will have professionals surveying the lake that will be more likely to identify new invasive species that are known to be coming as well as identify other potential lake problems promptly.

Lakeshore Environmental will be paid \$6800 annually for its services which include:

- 1. Bid out invasive plant treatment services and make recommendations to township boards
- 2. Conduct spring and fall vegetation surveys
- 3. Provide on-site oversight of herbicide application
- 4. Provide a Lake Progress Report on past treatment efforts and proposed future treatment efforts
- 5. Provide information to Township Boards on lake ecological status and factors affecting the ecological balance of the lake
- 6. Attend up to 3 township or SLIA meetings
- 7. Provide assistance with future special assessment districts or public hearings

As of May 11, 2011 Blair and Garfield Special Assessment District accounts had a balance of \$18,992.64. That figure does not include revenues from the 2011 assessment.
